This is for information of all concerned that as per the Admission Notification No. 1/2021 Dated 03/08/2021 the following **admission procedure** shall be followed for admission into the **Five Year Integrated MA in Sanskrit (IMS) / Sanhata Shastri Acharjya Programme** under School of Sanskrit Studies with semester system in Kumar Bhaskar Varma Sanskrit & Ancient Studies University, Nalbari for the Academic Session 2021-2022.

- 1) Publication of Provisional Merit List : 03/09/2021
- 2) Date of Admission (**offline**) : 07/09/2021 (**11 am onwards**)

**N.B:**

- Merit list of candidates is prepared on the basis of the percentage of marks secured in the qualifying examination.
- Existing provision of reservation shall be applicable in all programme.
- Admission process including admission from waiting list will be completed on the same day. **No request for admission will be entertained after the said day.**
- Any complaint regarding provisional merit list may be submitted within **04<sup>th</sup> September, 2021** on or before **11 am** positively by **e-mail ([kbvsasuhelpdesk@gmail.com](mailto:kbvsasuhelpdesk@gmail.com))**.
- Any Candidate, who furnishes false information/declaration at the time of online form submission or offline admission, his/her admission is liable to be cancelled at any point of time. Criminal proceedings shall be taken against such candidates for submission of false, fabricated documents/information under appropriate law.

**Instruction regarding Admission Procedure:**

1. **The selected candidates will be admitted provisionally. The details about fees to be paid will be notified in due course in compliance with order of Government of Assam.**
2. The admission process will be done on the university premise only.
3. During the time of admission the applicant must submit photocopies of two set of all documents from HSLC onwards.
4. The applicant must produce the following documents in original during the time of admission which is earlier uploaded in the time of online application.
  - a. Acknowledgement of Online application.
  - b. Acknowledgement of Unique Id
  - c. HSLC or equivalent examination admit card, Mark sheet and Certificate
  - d. HSSLC or equivalent examination Mark sheet and Certificate
  - e. Aadhaar Card/PRC/Voter ID (applicants' or parents)/Domicile Certificate
  - f. Other qualification mark sheet (if any)
  - g. Caste certificate if other than general category.
  - h. Gap certificate (for applicants who passed qualifying examination in the year 2019 and 2020).
  - i. Extra-curricular certificates (if applying under EC quota).
  - j. PWD (person with disability/specially abled category) certificate as applicable.
5. If any candidate has not collected the original Marksheet and Certificate from their respective institutions then Authority will give their admission on the basis of marks show in online Marksheet. But he/she will have to submit their original Marksheet and Certificate in due time.
6. The applicant who gets admission to the university must submit an affidavit of **Anti-Ragging** declaration at his/her own cost. This facility may be available in the time of admission in the University Campus.
7. Candidates who come late or does not turn up at the stipulated time will be considered absent and the respective seat will be filled up from waiting list.
