Short title and commencement

- (1) These rules may be called as the Assam Education
 Department Rules and Orders, 1955(Amendment)
 Rule, 2017.
 - (2) They shall come into force on the date of their publication in the Official Gazette.

Substitution of Section 44

- In the principal Rules, for the existing section 44, the following shall be Submitted namely
- "Section 44 With effect from the date of commencement of the Kumar Bhaskar Varma Sanskrit and Ancient Studies University (Amendment) Act, 2017 the following function relating to Sanskrit Tols shall be exercised by the Kumar Bhaskar Varma Sanskrit and Ancient Studies University in view of the provisions of the said Act.

The Director may place the services of the staff at the disposal of the Kumar Bhaskar Varma Sanskrit and Ancient Studies University.
- (d) The Deputy Director shall exercise his power under the Director of Higher Education.
