16. Multidisciplinary / interdisciplinary

The Kumar Bhaskar Varma Sanskrit and Ancient Studies University has always been keen on providing a platform for multidisciplinary education for the holistic development of the learners as well as the faculty members. As such, though Sanskrit and Ancient Studies have been core focus of the University, since its inception, as per the University Act, the University has been offering programmes and courses relating to humanities and social sciences as well. Indeed, there is also a school of Humanities and Social sciences with Assamese, Education, Philosophy and Political Science departments under it.

It is important to note that across different programmes number of courses are offered in emerging areas with cross-cutting significance which are essentially multidisciplinary in nature. Moreover, the 2nd semester PG students of all social science disciplines have to mandatorily opt for functional Sanskrit course where as the 2nd semester PG students of all Sanskrit programmes have to opt for any of the Value-added courses offered by the Non-Sanskrit Departments. Similarly, in case of research at the University, interdisciplinary approach is appreciated and encouraged.

On the other hand, the NEP-2020 based framework of four-year Undergraduate Programme (FYUGP) of the University has been finalized on 20th May, 2023. With a view to create a learner centric educational environment, the university is determined to implement a multi-disciplinary approach thereby allowing the learners to navigate across courses of various disciplines. As such, under the new curriculum, the students may opt for various Ability Enhancement Courses, Interdisciplinary courses and value-added courses from across a pool of courses offered by the various departments.

17. Academic bank of credits (ABC):

The university has implemented Academic Bank of Credit in the month of November, 2022. Till date, 90% students of the university have registered in the digilocker account and they have already generated

their ABC id.

18.Skill development:

The University has always emphasized on value and skill-based education for meaningful and holistic development of the students. As such, through various programmes, the University has offered a number of courses for enhancing skills. These include Diploma in Karmakanda Prashikshanam (DKP), Post-Graduate Diploma in Gandhian Studies (PGDGS), Post Graduate Diploma in Yogic Science and Therapy (PGDYST), Certificate courses on Jyotish Shastra (CCJS), Certificate courses on Saswar VedaPatha (CCSV) and Certificate courses on Computer Application (CCA). On the other hand, as part of the existing PG programme a number of courses are offered that have direct bearing on the skill aspect of the learners. These include Course on Functional Sanskrit (mandatory for all non-Sanskrit PG 2nd semester students), Internship programme as part of MA Education and Value-added Course on Sanganak Kaushalam as part of MA SVS.

19.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The Kumar Bhaskar Varma Sanskrit and Ancient Studies University has always accentuated on the significance of ancient Indian Knowledge System and made an attempt at reflecting and integrating the same in the vision-mission statement as well as curriculum of the University. Being a Sanskrit and Ancient studies University, all the courses across the School of Sanskrit are related to Indian Knowledge system and they are taught in Simple Standard Sanskrit Language. As such, the curriculum reflects integration of the elements of Gyan-Vigyan and Jeevan Darshan Parampara of Ancient India. On the other hand, the curriculum of the department of Assamese is primarily focussed on the literature, culture and linguistic aspect of the Assamese Language. The rest of the non-Sanskrit departments exercise teaching in bi-lingual mode (English as well as Assamese). However, certain elements of the Ancient Indian Knowledge system have also been incorporated as part of their respective curriculum.

The University has always focussed on outcome-oriented learning and outcome-based education system. Thus, the Course Outcome, Program Outcome (IMS) and Program Specific Outcomes of the University are clearly stated as part of the curriculum. These are aimed at inducing graduate attributes in the students rendering them human resource which will further help in the process of nation building. As such, the curriculum of the University is aimed at inculcating

moral values as well as preparing them for getting meaningfully employed once they pass out.

2.5.3 - IT integration and reforms in the examination procedures and processes (continuous internal assessment and end-semester assessment) have brought in considerable improvement in examination management system of the institution

The examination system of the University is integrated with ICT since August 2019 which includes online notification of examination, online application for examination, online generation of admit cards, online declaration of result, online mark sheets and provision of online application for revaluation have been made available for the students.

The University has joined the National Academic Depository (NAD). It has facilitated the students to access their certificates through digital mode without the need to carry original documents.

The University ensures that the results of end-semester examinations are declared within a minimum period of time. Declaration of results within a stipulated time has helped the outgoing students in immediately exploring future course of action.

The University follows grading system since 2017-18. The final grades are computed using a cumulative grading formula based on the credits earned in each course, and the total scores of internal and external assessments.

The University follows Continuous Internal Assessment of students through sessional examinations, home assignments, seminar presentations, group discussions, field works, projects and class attendance. The ratio of internal assessment and final examination is 20:80. It provides early indication of students' performance and provides opportunities to the students for their continuous improvement.

The attainment of learning outcomes is evaluated mainly through the examination system of the University. The system comprises Summative and Formative assessment to evaluate the academic performance, knowledge attainment, academic learning and individual growth of the students.

Under Summative assessment, end-semester examination is conducted every six months. It comprises 80% of the total evaluation of a student. Formative assessment consists of sessional examinations, group discussions, seminar presentations, home assignments, field study and attendance. It comprises 20% of the total evaluation.

Field study and excursion programmes are conducted to engage the students in gaining practical experiences and applied knowledge. The MAEDN and DKP programmes include a practical course, for which also both internal and external evaluation is conducted.

The level of attainment of the outcomes is also evaluated by monitoring their leadership quality, socio-political awareness, participation in team work, communication and other skills through

their performance in various co-curricular activities like preparing of hand-written magazine and wall-magazine, sports events, cultural activities, literary and fine arts events, social service, etc. for their holistic development.

7.2.1 - Describe one best practice successfully implemented by the Institution as per NAAC format provided in the Manual

Title: Popularization and Promotion of Sanskrit through Sanskrit Vikas Kendra

Objectives: The Sanskrit Vikas Kendra (SVK) was established to promote and propagate Sanskrit. The objectives are--

- To bring cognitive development.
- To develop mastery of Sanskrit language.
- To connect people to ancient Indian culture and heritage.
- To provide direct access to knowledge available in ancient Indian scriptures and texts.

Underlying Principle: Acquainting students with Sanskrit gives them scope to explore various value-based texts.

Context: In the context of Providing opportunity of knowing our rich heritage and learning Sanskrit in a joyful manner.

Practice: SVK organizes Spoken Sanskrit Camps for different target audiences. Birabala Kanakalata Barauh Balakendram under SVK enrolls children (3-6 years) from neighbouring areas. They are taught basic Sanskrit through short stories, songs, stotras.

Evidence of Success: 137 students participated in Balakendram. Children are found to converse easily in Sanskrit at their homes too. The relation between local community and University increased exponentially through this.

Problems and Resources: Many people consider Sanskrit as a tough subject and are skeptical about its practical utility. It is a challenge to encourage parents to send their children for evening classes to learn Sanskrit. The SVK would perform better with better facilities for promoting Sanskrit.

7.3 - Institutional Distinctiveness

7.3.1 - Highlight the performance of the institution in an area distinct to its priority and thrust

(within a maximum of 200 words)

Being the one and only Sanskrit university in the north eastern part of India, the University is able to uphold its own unique characteristics and stand as an institution with its distinctiveness. One of the most distinctive features of the University is its efforts towards popularizing Sanskrit learning in North-East India, a place inhabited by large tribal population. The University caters to the educational needs of a remote place in Assam where most of the students are from socio-economically marginalized section of the society. A distinctive performance of the University is being able to encourage girl students and tribal students (both marginalized sections of the society) to access and excel in the higher education level, particularly in Sanskrit learning.

Moreover, in an effort to build a bridge between ancient Indian education system and modern education system, the University has simultaneously ensured availability of Yajñashala and Open Air classroom (Krishna Kanta Handique Muktaneelkasha) as well as ICT-enabled classrooms.

7.3.2 - Plan of action for the next academic year

The plan of action of the University for the academic year 2022-23 includes-

- Starting FYUGP in the line of NEP 2020.
- Organizing spoken Sanskrit Camps in different places as outreach programmes for promotion and propagation of Sanskrit.
- Organizing evening classes for the women of the neighbourhood for Spoken Sanskrit.
- Completing the recruitment process for administrative, teaching and non-teaching sanctioned posts.
- Organizing training for the non-teaching staff.
- Bringing better ICT facilities to the students by purchasing more computers
- Installation of CCTV cameras in the New Academic Building for better surveillance.
- Construction works for infrastructural development like renovating the playground, construction of car parking shed, etc.
