16.Multidisciplinary / interdisciplinary

The Kumar Bhaskar Varma Sanskrit and Ancient Studies University has consistently prioritized in providing a platform for multidisciplinary education to foster the holistic development of both learners and faculty members. While Sanskrit and Ancient Studies have been the core focus of the University since its inception, in accordance with the University Act, it has also been offering programmes and courses in humanities and social sciences as the university focuses on both occidental and oriental learning. Notably, the University also has School of Humanities and Social Sciences, which includes departments such as Assamese, Education, Philosophy, and Political Science. Across various programmes, a range of courses in emerging areas with cross-cutting significance are offered, emphasizing their multidisciplinary nature. Additionally, all second-semester PG students in social science disciplines are required to take a Functional Sanskrit course, whereas second-semester PG students in Sanskrit programmes must choose from the Value-Added courses offered by non-Sanskrit departments. Similarly, in research, the University actively promotes and encourages an interdisciplinary approach. Furthermore, the framework for the NEP-2020-based Four-Year Undergraduate Programme (FYUGP) at the University was finalized and admitted the first batch in the 2023-24 academic session. To create a learner-centric educational environment, the University is committed to implementing a multidisciplinary

approach, enabling students to explore courses across various disciplines. Under the new curriculum, students can select from a diverse range of Ability Enhancement Courses, Interdisciplinary Courses, Value-Added Courses and Skill Enhancement Courses offered by different departments.

17.Academic bank of credits (ABC):

The university has implemented Academic Bank of Credit in the month of November, 2022. Till date, 95% students of the university have registered in the digilocker account and they have already generated their ABC id.

18.Skill development:

The University has always focused the attention on value and skill-based education for meaningful and holistic development of the students. Through various programmes, the University has offered a number of courses for enhancing skills. These include Diploma in Karmakanda Prashikshanam (DKP), Post-Graduate Diploma in Gandhian Studies (PGDGS), Post Graduate Diploma in Yogic Science and Therapy (PGDYST), Certificate courses on Jyotish Shastra (CCJS), Certificate courses on Saswar VedaPatha (CCSV) and Certificate courses on Computer Application (CCA). On the other hand, as part of the existing PG programme a number of courses are offered that have direct bearing on the skill aspect of the learners. These include Course on Functional Sanskrit (mandatory for all non-Sanskrit PG 2nd semester students), Internship programme as part of MA Education and Value-added Course on Sanganak Kaushalam as part of MA SVS. Apart from these, several skill development courses are also have been implemented under FYUGP-such as Political leadership, Short film production, manuscriptology, cyber security etc.

19.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)

The Kumar Bhaskar Varma Sanskrit and Ancient Studies University has consistently emphasized the importance of the Ancient Indian Knowledge System, striving to reflect and integrate its essence into the University's vision-mission statement and curriculum. As a Sanskrit and Ancient Studies University, all courses under the School of Sanskrit are centered around the Indian Knowledge System and are taught in Simple Standard Sanskrit. Consequently, the curriculum embodies the integration of Gyan-Vigyan and Jeevan Darshan Parampara from Ancient India. Meanwhile, the curriculum of the Department of Assamese primarily focuses on the literature, culture, and linguistic aspects of the Assamese language. The other non-Sanskrit departments follow a bilingual mode of instruction, using both English and Assamese. However, elements of the Ancient Indian Knowledge System have also been incorporated into their respective curricula. The university also has incorporated several value addition courses (Environmental studies, Yoga, NSS etc) under the FYUGP from the academic session 2023-24 which also carries the relevance Indian Knowledge system.

20.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):

The University has always made emphasis on outcome-oriented learning and outcome-based education system. Thus, the Learning Outcome, Course Outcome, Program Outcome (IMS) and Program Specific Outcomes of the University are clearly stated as part of the curriculum. These are aimed at inducing graduate attributes in the students rendering them into a human resource which will further help in the process of nation building. As such, the curriculum of the University is aimed at inculcating moral values as well as preparing them for getting employment once they pass out.

21.Distance education/online education:

A study centre of K.K. Handiqui State Open University was established in May, 2023 at the Kumar Bhaskar Varma Sanskrit and Ancient Studies University bearing centre code 2219 to offer open and distance learning for various aspiring learners. For the purpose of offering various courses to the aspiring learners, the centre in-charge and coordinator of the study centre convened an orientation programme during the 'Student Induction Programme' of KBVS&AS University's newly admitted students on 10th August, 2023. The study centre offered courses for both UG and PG Programmes as well as various Diploma courses under NEP, 2020 viz., Assamese, Economics, Education, English, History, Political Science, Sociology, etc. The centre has also undertaken various awareness programmes to enlighten students about the benefit of dual degree as per the regulation of the University Grants Commission. For the greater interest of inclusive education, the centre has also undertaken initiatives to accommodate admission into the study centre in various courses through banners, posters and awareness programmes by visiting localities as well as existing academic Departments of the University. For the academic session 2023-2024 (NEP 2020) a total of 14 learners have enrolled for various courses and programs at the study centre. The first batch of the study centre has already appeared in the recently held first semester examination, 2024.

2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

The University follows the norms of a continuous evaluation system when assessing students. It takes into account factors such as attendance, participation in class discussions, assignments, seminar presentations, group discussions, sessional examinations, and the end-semester examination.

The University's Pre-Examination Training and Counseling Centre offers training programs of 4-6 months' duration to guide students preparing for SET/NET-JRF and other competitive exams. Students enrolled in the Diploma in Karmakanda Prashikshanam program organize various rituals, offering them practical experience.

The University encourages advanced learners to:

- 1. Appear for NET/JRF/SLET and other competitive exams with guidance from the Pre-Examination Training Centre.

2.5.3 - IT integration and reforms in the examination procedures and processes (continuous internal assessment and end-semester assessment) have brought in considerable improvement in examination management system of the institution

The University has integrated ICT into its examination system since August 2019. This includes online notifications of examinations, online application submission, online admit card generation, online result declaration, online mark sheets, and the provision for online revaluation applications.

The University has also joined the National Academic Depository (NAD), allowing students to access their certificates digitally, eliminating the need to carry original documents. The University ensures the timely declaration of end-semester examination results, enabling outgoing students to promptly plan their next steps.

Since the 2017-18 academic year, the University has adopted a grading system. Final grades are calculated using a cumulative grading formula, which considers the credits earned in each course and the total scores from both internal and external assessments.

The University employs a Continuous Internal Assessment (CIA) system, which includes sessional exams, home assignments, seminar presentations, group discussions, fieldwork, projects, and class attendance. The internal assessment for MA programme contributes 20%, while the final examination accounts for 80% of the total grade. It is to be mentioned that from the academic session 2023-24, 40:60 ratio has followed in formative and summative assessment under FYUGP programme. This system provides Processing

early feedback on student performance, offering opportunities for continuous improvement.

The attainment of learning outcomes is primarily assessed through the University's examination system, which includes both summative and formative assessments to evaluate students' academic performance, knowledge acquisition, and overall development.

Summative Assessment: The end-semester examination, conducted every six months for MA forms the basis of summative assessment and accounts for 80% of a student's total evaluation while for FYUGP programme, it has been counted as 60%.

Formative Assessment: This includes sessional examinations, group discussions, seminar presentations, home assignments, field studies, and attendance, contributing 20% to the total evaluation for MA and 40% for FYUGP. Field studies and excursion programs are designed to provide students with practical experience and applied knowledge.

The MAEDN and DKP programs include practical courses, which are also evaluated through both internal and external assessments.

Holistic Development: The attainment of learning outcomes is further evaluated by monitoring students' leadership qualities, socio-political awareness, teamwork, communication skills, and other abilities through their participation in various cocurricular activities. These activities include preparing handwritten magazines and wall magazines, sports events, cultural activities, literary and fine arts events, and social service, all of which contribute to their holistic development.

The learning level and achievement of outcomes are also assessed based on students' success in examinations like the NET, SET, and other competitive exams.

INFRASTRUCTURE AND LEARNING RESOURCES

- 5 ICT classrooms with smart digital devices, Wi-Fi facilities, and other essential resources for both students and staff.
- A Manuscript Repository located within the library.
- Departmental libraries for each academic department.
- Computer and printing facilities available in all departments.
- 1 Conference Hall that also functions as an ICT classroom.
- 1 VC's Conference Hall with ICT capabilities.
- 1 Computer laboratory containing 10 computers.
- 1 Psychological laboratory with necessary apparatus and seating arrangements for both the experimenter and the subjects. The laboratory is equipped with instruments such as stopwatches, wooden screens, memory drums, a

tachistoscope, human maze learning boxes, mirror drawing apparatus, Bhatia's Battery of Performance Tests, steel almirahs, desks, benches, and a whiteboard.

- 1 Yajnashala and 1 room for yoga practice.
- A Central Library that houses a large collection of books, journals, and magazines. The library provides students and staff with newspapers in Sanskrit, Assamese, and English. It also offers photocopying and printing services.

- Badminton Court: 13.4 meters in length and 6.1 meters in width.
- Sporting Equipment: Students have access to football,

cricket, volleyball, tug-of-war, badminton, and carrom equipment throughout the year.

Varsity Festival: The University organizes the following programs annually:

Curriculum Development for NEP-2020 Implementation In preparation for the implementation of NEP-2020, the IQAC played an active role in ensuring that the curriculum for the FYUGP (Four-Year Undergraduate Programme) was ready before the commencement of the 2023-24 academic session. The University's NEP Implementation Committee worked closely with the academic departments to develop the NEPaligned curriculum. As a result, the syllabi from various departments were compiled and made available on the University website, following the direction of the IQAC.
- 2. Annual Quality Assurance Report (AQAR) Initiatives Following the first cycle of accreditation and assessment of the University in 2022, the IQAC began the process of institutionalizing the AQAR submission for maintaining institutional discipline and preparing for the next phase of assessment. The IQAC held multiple meetings with the DQACs to facilitate this process. The submission of the AQAR for the academic session 2023-24 is being done through a collaborative and democratic process, in

consultation with NAAC via the online portal.

7.2 - Best Practices

7.2.1 - Describe one best practice successfully implemented by the Institution as per NAAC format provided in the Manual

Title: Popularizing and Promoting Sanskrit through Sanskrit Vikas Kendra

Objectives: The Sanskrit Vikas Kendra (SVK) was established with the aim of promoting and propagating Sanskrit. Its objectives include:

- Facilitating cognitive development.
- Developing mastery of the Sanskrit language.
- Connecting individuals with ancient Indian culture and heritage.
- Providing direct access to knowledge contained in ancient Indian scriptures and texts.

Underlying Principle: Introducing students to Sanskrit offers them the opportunity to explore various value-based texts. Context: The initiative seeks to provide an enjoyable learning experience for individuals interested in understanding India's rich heritage while learning Sanskrit.

Practice: SVK organizes Spoken Sanskrit Camps targeting various audiences. The Birabala Kanakalata Barauh Balakendram, under SVK, enrolls children aged 3-6 from the surrounding areas. These children are introduced to basic Sanskrit through short stories, songs, and stotras.

Evidence of Success: A total of 300 students enrolled in the Balakendram from within and outside the campus under the aiges of SVK, Kumar Bhaskar Varma Sanskrit and Ancient Studies University. Many children have become proficient in conversing in Sanskrit, even at home. The connection between the local community and the University has significantly strengthened through this initiative.

Challenges and Resources:

Sanskrit is often viewed as a challenging subject, and many people remain skeptical about its practical utility. Encouraging parents to send their children to evening Sanskrit classes remains a significant challenge. The SVK could perform more effectively with enhanced facilities to promote Sanskrit.

7.3 - Institutional Distinctiveness

7.3.1 - Highlight the performance of the institution in an area distinct to its priority and thrust (within a maximum of 200 words)

As the only Sanskrit university in the northeastern region of India, the University has successfully maintained its unique identity and stands out as an institution with distinct characteristics. One of its most notable features is its commitment to promoting Sanskrit education in North-East India, a region with a large tribal population. The University serves the educational needs of a remote area in Assam, where many students come from socio-economically disadvantaged backgrounds.

A remarkable achievement of the University is its ability to encourage and support girls and tribal students—both marginalized groups—towards accessing and excelling in higher education, particularly in Sanskrit studies.

Furthermore, in its efforts to bridge the gap between ancient Indian education and modern educational practices, the University has ensured the availability of both traditional facilities like the Yajnashala and the Open Air Classroom (Krishna Kanta Handique Muktaneelkaksha), as well as modern ICT-enabled classrooms.

7.3.2 - Plan of action for the next academic year

The University's action plan for the academic year 2024-25 includes the following initiatives:

- Launching of Integrated BEd programme in alignment with NEP 2020.
- Organizing Spoken Sanskrit Camps at various locations as outreach programs to promote and propagate Sanskrit.
- Conducting evening classes in Spoken Sanskrit for women in the surrounding community.
- Completing the recruitment process for administrative, teaching, and non-teaching staff in sanctioned positions.
- Offering training programs for non-teaching staff.
- Enhancing ICT facilities for students by purchasing additional computers.
- Undertaking infrastructure development, including the renovation of the playground and the construction of a car parking shed.
- Establishing an IKS centre in the campus
- Adoption of Schools and villages in neighbouring areas
