MAPSCC 402 POLITICS AND POLITICAL PROCESSES IN NORTH EAST INDIA

Course Objectives: This paper offers students to the themes, concepts and debates that underlie the study of political history of North East region, diverse and complex social structures, and discourses of ethnicity, nationalism, socio-political and cultural identities which eventually has had led the state apparatus (from colonial to postcolonial period) to introduce series of administrative mechanisms. The course will offer students to interrogate over manifold policy implementations and their implications over the politics and political processes in India's North East.
